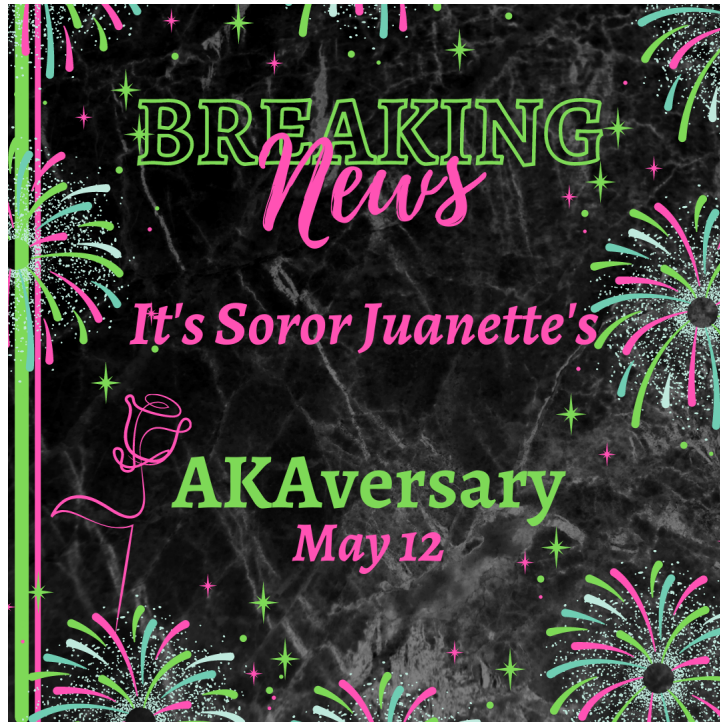



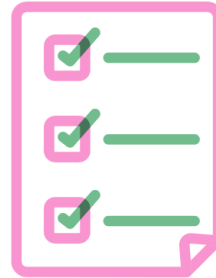

## **Day 1**

- AKA Day at the Capitol began with Soror Tifara Monroe sharing a variety of updates from the International Connection Committee and major events of the last couple of years. Following the updates several
  - AKA Established a Legislative Agenda in 2018
  - Federal Priorities forwarded to the 117<sup>th</sup> Congress
    - Target 1 Every Student Succeeds Act
    - Target 2 Uphold Affordable Care Act
    - Target 5 Global Impact- Violence Against Women Act
  - American Rescue plan Passed in March 2021
  - Biden-Harris Administration reached 100<sup>th</sup> day in Office April 30, 2021
  - Historically Diverse Congress
  - George Floyd Act
  - Congressional Black Caucus 58 members
  - 6 AKA members are in congress
  - Voting issues
  - Congresswoman Barbara Lee (CA) spoke on how black women drive political change.

- Congressman Steven Horsford (Nevada) was the keynote speaker. The congressman was the first African American State Senate Majority Leader and also a member of Alpha Phi Alpha Fraternity, Inc. His wife Dr. Sonya Horsford is a 27-year member of AKA serving in Theta Theta Omega.
  - Describes voter suppression laws as Jim Crow 2.0.
  - The congressional black caucus met with President Biden and Kamala. Harris for 2 hours about strong protections of voting rights 4/13/21.
  - HR1- For the People Act (Protects Voting Rights)- Co-sponsored with 270 other democrats keeping “dark money’s corporations out of elections.
  - HR4 (John Lewis Bill) key bill to get passed and signed by the President HR4 already passed the house with bipartisan support.
  - Mid-term elections are crucial to push items through and not lose the House in 2022
  - HR 4 will be voted on before Independence Day as promised by Speaker Pelosi.

#### **Day1 Breakout Rooms**

- Senator Sydney Kamlager (Zeta Phi Beta)- Recent accomplishments including Prop 17 restoring voter rights to felons, allowing citizens to change their political party on the day of the election, and register to vote on the day of the election.
- The C.R.I.S.E.S Act was vetoed by the governor due to wanting it to be led by law enforcement. The main goal is to get law enforcement out of the equation and have more intervention services like mental health.

The Protocol topic for the month of May is focused on The Alpha Kappa Alpha Pledge and The Alpha Kappa Alpha National Hymn. Attached is a PowerPoint covering this important topic. These guidelines are taken from The Official Guide to Alpha Kappa Alpha Protocol Manual 2020 Edition page 9.



### Protocol Guidelines for AKA Pledge

-  All sorors should be able to recite the Pledge by memory.
-  When reciting the Pledge, there is no “s” on the word strength.
-  The Pledge should be recited at the beginning or end of chapter meetings.
-  When reciting the Pledge after the Hymn, keep arms crossed (right over left) and hands clasped, conclude with a gentle, inconspicuous hand squeeze.
-  The Pledge should never be printed on any item.
-  The Pledge should not be recited publicly.

The official sorority song is Alpha Kappa Alpha National Hymn.



The Hymn should be sung at a brisk pace.



Sorors should note the following when singing the Hymn:

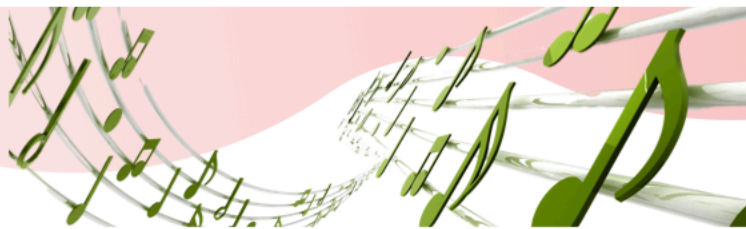
Sorors should not cross arms when singing the Hymn in public.
