 - b. 53 mill in AKA assets
 - c. Money saved during the pandemic
- 6. Member health/safety and sanity are of paramount concern to Madam Supreme
 - a. AKA Stimulus package 2021 \$125 to \$100 per capita tax, \$25 reduction for the 6 month period (Aug-Feb)
 - b. Chapters Recommendation is to not increase fees and even reduce chapter dues if possible. Consider refunding any savings.
