

#### OFFICER REPORTS

##### Basileus Report

Basileus, Soror Juanette Sharee G. Clark presented the following:



- Continue to report any Sorors and family members who test positive for Covid-19.
- Congratulations to Soror, Madam Vice President Elect Kamala Harris. Thank you to Divine 9 and other social and justice organizations for their contributions in making history for the Black Female vote.
- Kudos to Soror Jessica for creative artistry work as Connections Chairman and to the Technology Chairman Soror Marsha Overton-Dodson for getting out all the VOTE flyers and posting them to our social media pages.
- For more information on why the SCBC was dissolved reference our Constitution & Bylaws (Article II Section 8). The Basilei Councils were designed to build comradery and encourage best practice sharing among chapter Basilei; they are not established entities within our sorority. Aside from corporate, we have regions, clusters, and chapters. According to our Bylaws those are the only entities authorized to have checking accounts, bylaws, and officers. Effective January 2021 members will include current chapter basilei. No longer past Basilei will be a part of the SCBC. There will be no annual dues, bylaws or bank accounts associated with the council. Meetings will be held quarterly. (February (Leadership retreat), May, August (Sisterly Relations) and November.
- Congratulations to Soror Charisma for being instrumental in coordinating and participating in the NBC 4 News interview about Soror Kamala Harris along with MRD Soror Shelby Boagni, and other Sorors on her historic win. The only Soror who can speak to the press is MSB.
- Regional Founders' Day is Saturday January 30, 2021, and it will be virtual. The Host Chapters are Delta Upsilon Omega, Epsilon Xi Omega, Rho Delta Omega, and Alpha Alpha Iota Omega. The cost will be minimum. Details are forthcoming from the FD Committee. For this FD our RD Leadership team is working on allowing inactive Sorors to join in as part of the Reclamation Initiative since no rituals will be taking place.
- End of Year Reporting assistance is available, and the Program Committee will be hosting a webinar on December 1, 2020. Email information forthcoming.
- Directorate voted to move forward with Fall MIPs on 4 undergraduate chapters that were interrupted due to COVID. If the current undergraduate chapters are not allowed to complete the process, there will be zero members. There is only one chapter in the FWR located in Seattle, WA. We are not allowed to have any rituals virtually. The sessions will be restructured over a period of 8 days with only the 1<sup>st</sup> and the last day in person.
- Next monthly update from MRD will be December 1, 2020 and will include some fun upcoming Regional activities.
- There is still time to send in entry photos and a write up to Poised and Progressive in order to highlight our virtual programs. Deadline is extended to November 20, 2020.



**December 20, 2020**

- I. On December 1, 2020 attended the International Program Committee Webinar.
  - a. Program Enhancements include the Wear a Mask Campaign, Grow with Google, and Feeding Children Everywhere.
  - b. As an organization we have collected 410,000 shoes for Soles for Souls. Continue to collect, we are only at 39% of the Far Western Region's (FWR) 31,650 goal.
  - c. Heavy emphasis to continue to make Pillowcase Dresses (73% - 2,308 to our FWR goal of 3,165), but more so for Pillowcase Shirts (37% - 579 to our FWR goal of 1,583).
  - d. Madam Supreme did put out communication that a maximum of for Sorors could come together for no more than an hour to collect shoes and glasses under Target V, but that is not permitted in the FWR or for any other Target initiative.
  - e. Please work to continue coordinating Refugees in America Assistance Program efforts, including volunteering with English as a Second Language opportunities held virtually and donating items for the holidays.
  - f. End of Years Reports are due 12.31.2020 at 11:59pm – the reports are the same as last year. The virtual form was merely to help chapters capture there virtual program information and will not be uploaded or turned in anywhere.

- g. There will be 2020 Virtual Program Awards – Guidebook on the way.

II. On December 10, 2020 attended the Far Western Region Basilei Council Meeting.

- a. International Membership Committee (Chair: Soror Tracey Morant Adams and Far Western Region Rep Soror Desiree E. DeShay) presented to the Council highlighting the Reactivation 5K Initiative.
  - i. Chapters should look to hold a reclamation event on 1.15.2021. Some ideas are A-Kall-A-Thon.
    - 1. Reactivation Day Goals: 25 for XL Chapter, 15 for L Chapter, 10 for M Chapter, 5 for a S size Chapter.
  - ii. Alpha Gamma Omega and Alpha Nu Omega Chapter won the 2019 reclamation award each bringing back seven (7) Sorors.
  - iii. Thus far the 2018-2022 Reactivation Workplace has reclaimed 22,937 pearls.
  - iv. There is a Welcome Home Toolkit available for chapters to provide to newly reclaimed pearls to help facilitate the transition back to sisterhood.
